- Supervised Free Time (5:00-6:00)



Upon arrival to Isaac's Martial Arts, students will change into their uniform and be seated for Home work and Snack time. Our staff will assist with the homework and insure to the best of our knowledge that it is completed before class, keep in mind we will not tutor the students, as that is the parent's responsibility. Please be sure children have their own homework supplies. After homework is completed, the students will have their Martial Arts class or Fitness fun class which will last approximately 45-60 minutes. Karate and Fitness fun will be Monday thru Thursday. Friday is reserved for OUR FRIDAY FUN DAY!!

A NOTE ABOUT THE UNIFORM — The Martial Arts Uniform (Gi) is to be treated with respect. This shows unity and pride in our school. The Uniform should be kept neat and clean at all times. Each child will be provided with Hangers for their uniform and taught how to neatly hang their uniforms in their assigned lockers. Uniforms are to be taken home each Thursday to be cleaned and returned by Monday. We are as interested in your child's growth and education as you are. IMAC after school offers an incentive program for good behavior as well as good report cards in the form of patches that can be earned; if your child earns a patch please sew them on as soon as possible and as instructed. Martial Acts Testing Foe's and Equipment

As in any sport there is equipment and uniforms to purchase as needed. Martial Arts are no exception. You will receive (1) uniform at the time of registration extra uniforms may be purchased through the school at \$45.00. Sparring gear is a necessary purchase for martial arts to insure your child is properly protected and free from harm, you may purchase this gear any time before your child becomes an Orange belt at which time the gear is required for continuing lessons and growth, Sparring gear may be purchased through the school for \$89.00 per set. Every 2-3 months depending on your child's skill and level of preparation they will be invited for belt testing. The fee for testing is included in your after school care payments, so no worries. When passing a Belt test the student is awarded a new Belt and World Recognized promotional certificates in Isshinryu Karate as well as Traditional Jujitsu training.

- 1. Payments are due either monthly on the 1st or weekly on the Friday for the Following week. Any weekly payment received after Tuesday will be assessed a \$25.00 late fee. All payments are to be set up on an approved form of auto draft.
- 2. If your child takes an extended break from our program other than summer break, a new supply fee will be due when they resume the program.
- **3.** Pick up time for After School Care is 6:00pm. If you are going to be later than 6:00pm please call IMAC at (336)512-1646. If you are in need of extended pick up times you may choose to have your child participate in our 6:15 Warriors kids class for an additional charge of \$8.00 per class.
- **4.** ABSS early release days, IMAC will provide pick-up and drop off services as usual: Warriors package members will be charges a discounted rate of \$5.00 per child and basic members a rate of \$10.00 per child payable the day prior to early release if your child plans on attending.
- 5. ABSS Teacher Workdays: IMAC will provide full day care with drop off beginning at 7:30 (we require at least 8 children signed up to provide care) Full day camps are provided to Warriors package members at a discounted rate of \$9.00 per child and Basic members at a rate of \$18.00 per child and is payable the day prior to service.
- 6. Regarding inclement Weather and School Closings. Your Child's safety is our first concern. If school is cancelled or dismissed early due to severe weather conditions we WILL NOT pick up or Operate Camps. We follow the ABSS inclement weather protocol. In this event please make other arrangements to pick your child up and have care provided.
- 7. On ABSS Teacher Workdays, IMAC requires at least (8) children be signed up in advance
- 8. There will be no refunds or adjustments for Winter Break, Spring Break, or absences from our program.

PARENTS RESPONSIBILITY CHECK LIST

- 1. Notify your School that Isaac's Martial Arts after school program will be picking up your child.
- 2. If your child does not attend school because he/she is sick, etc., you MUST notify IMAC as soon as possible at (336)512-1646 so that we may notify all drivers.
- 3. Payments are to be kept current at all times to insure your child's participation in our program.
- 4. Check our lost and found weekly if your child has lost any items.
- 5. Please be sure the write your child's name is the waist bank of the pants, and collar of the top of their uniform. All Equipment and belts must also be marked.
- 6. If you wish to cancel your participation in our program a 30 day written notice is required and all payments within the 30 day notice are due and payable to IMAC.
- 7. If you sign your child up for any of our early release pick up days or full day teacher workday camps and decide not to attend you are still liable for payment.

RULES FOR STUDENTS

- 1. Be at the appropriate place at pick up time.
- 2. Behave and BUCKLE UP in the Van/Car. NO EXCEPTIONS.
- 3. Change into your uniform as directed after snack is provided.
- 4. Put your things neatly in the locker that has been assigned.
- 5. During homework time, please be quiet and respectful of others who are also doing their homework. If you have a question or need help raise your hand. All children are asked to participate in reading or quiet arts and crafts if their homework is already complete or if they have none.
- 6. No running or Horseplay in the building.
- 7. Use inside voices.
- 8. Do not TOUCH, PUNCH, KICK, HIT, PINCH etc., another student or instructor. Please Respect other peoples space.
- 9. Follow all instructions and directions that are given by your instructor and Staff of IMAC.
- 10. No bad language or name calling is allowed at any time.

OUR, AFTER SCHOOL DISCIPLINE POLICY

Isaac's Martial Arts Warriors After School Program is NOT a Day care. Our program is based on the contract between Parents or Legal Guardian and their children for Martial Arts Classes and Training.

In order to maintain a safe and quality program, we occasionally find it necessary to discipline a student. We feel that effective and positive ways of behavior management are:

- 1. REDIRECTION: We will stop the child and calmly learn what has happened, why and how they see it, and then suggest other ways of handing the situation. Then we will redirect their attention to another activity.
- SEPARATION: We will have the child take a time out from the rest of the group and rest for a short period. This gives them the opportunity to calm down and reflect on their behavior. We will then explain other ways to good behavior and handling situations.

If a child's behavior remains problematic, a parent conference will be scheduled. If there is little to no improvement in the child's behavior after the parent conference, termination of enrollment may be necessary. Termination of enrollment will be at the discretion of Isaac's Martial Arts after school program administrative staff.

Please Note: We are a Martial Arts School first and foremost; we may at any time assign physical activity including push-ups, stances, laps, or sit ups for minor behavioral mishaps such as not following directions, and daily rules. These physical activities encourage your children to be mindful of daily rules as well as aid in their physical development

OUR AFTER SCHOOL SICK POLICY

- Please call us by 1:30pm if your child/children will not attend the IMAC After school program for any reason including illness. Daily attendance is taken and we DO need to know if your child/children will be attending
- 2. If your child/children become sick while in attendance in the program, IMAC will notify you and you are required to pick your child up as soon as possible.
- 3. Children running a fever of 100 degree or greater shall not attend the program while their symptoms are present or for at least 24 hours after the fever has broken.
- 4. Children with reoccurring vomiting or diarrhea shall not attend the program while symptoms are present and for at least 24 hours after vomiting or diarrhea have stopped.
- 5. If your child has a communicable disease/illness, you are required to notify IMAC so that the parents of their other children may be notified of the possible exposure.
- 6. Children who have had a communicable disease/illness may not return to the program until they have a doctor's note stating that they are no longer contagious.
